History

Helping Hand was started in 2008 by a group of CDOT employees who recognized an opportunity to help fellow CDOT employees who needed some financial assistance. A motorcycle poker run was started to raise funds, and in the first year \$3000 was granted to CDOT families around the state. After this event, our non-profit organization was established.

Today

Fast forward to today, a small committee of CDOT employees who volunteer their time have established a non-profit group that continues to help CDOT families around the state. As of mid-2023, Helping Hand has provided about \$170K in support to CDOT Employees and their families.

Financial Support

\$600 Grants: Awarded to those that are in need of a financial helping hand.

Scholarships: 4 Scholarships awarded per year.

- (1) 4-year Renewable (\$4k)
- (2-3) One-Time (\$1k)
- (1) One-Time Vocational Focused (\$1k)

Death Grants: \$1000 – Provided to families of CDOT employees killed in the line of work.

Holiday Help: Additional \$600 Grants awarded during the Holiday season.

Eligibility

Any current or retired CDOT employee that is in financial need after having experienced a life-changing event is eligible. Helping Hand defines a life-changing event as unforeseen emergencies that arise from medical conditions, fire, death, and other difficult circumstances.

No applicant will be denied eligibility on the basis of race, color, religion, gender, age, national origin, disability, sexual preference, or other non-meritorious factor.

If approved for a grant, this is a one-time monetary award of \$600. We do not give awards to pay for debt consolidation, credit card payments, litigation, poor financial planning, non-essential items, wage garnishments, taxes, bail, expenses related to vehicles, phones, cable services, life insurance, or other non-emergency expenses.
